**Purpose and legal basis of the processing – retention period:**

Purpose 1: to allow you to obtain and download the brochure relating to RGI Product Designer product.

*Legal basis of the processing*: execution of a request by the data subject. *Retention period*: Time required to follow up on your request.

Purpose 2: to send you newsletters and commercial communications relating to RGI's products and services.

*Legal basis for the processing*: consent of the data subject. *Retention period*: 24 months from when consent was collected.

Purpose 3: to send you communications regarding events including webinars, initiatives, workshops, symposia organized by RGI.

*Legal basis for the processing*: consent of the data subject. *Retention period*: 24 months from when consent was collected.

**Methods of data collection - Nature of data provision**

The data will be processed manually, electronically and telematic tools, with logics strictly related to the purposes referred to in this privacy notice and, in any case, by persons authorised to carry out these tasks, duly aware of the constraints imposed by the GDPR, equipped with security measures to guarantee the confidentiality of personal data and to avoid undue access to third parties or unauthorised personnel.

The communication of data for the fulfilment of purposes number 1 is mandatory as it is strictly functional to allow the Data Controller to let you download the brochure relating to the RGI Product Designer product.

#### **Recipients or any categories of recipients of personal data**

For the aforementioned purposes, we may share data with service providers appointed as Data Processors by RGI or RGI group companies that provide services to the latter (by virtue of agreements pursuant to Article 28 GDPR, as data processors) or to the Judicial Authority.

In the event of transfer of personal data outside the European Union, the transfer will take place in accordance with the provisions of the applicable legislation in force, in particular art. 45-47 of the GDPR and in the presence of suitable guarantee measures (e.g., an adequacy decision adopted by the European Commission, or the prior stipulation of the so-called "Standard Contractual Clauses" between the supplier and RGI S.p.A.).

#### **Your rights**

Each data subject has the right to request at any time from the Data Controller access to and copy of personal data, the rectification or erasure of the same, the limitation of the processing concerning him or her or to object to their processing, without prejudice to the lawfulness of the processing based on the consent given before the withdrawal. When exercising the right of access, the data subject has the right to know whether his or her data is being processed, what the purpose of the processing is, what categories of data are processed, who are the recipients or categories of recipients to whom his or her data are communicated (and, if they reside in a third country, on the basis of which safeguards), the retention period of your data (or the criteria for determining the retention period), whether automated processing is taking place (e.g. by means of profiling) and what is the logic of such processing, the origin of the data (if they are not initially collected by RGI). Each data subject also has the right to lodge a complaint with the Data Protection Authority under the conditions and within the limits provided for by art. 13 of the GDPR.
